AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Liberty Lake from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (public works and capital purchases)
- Building permit revenues
- Financial condition
- Payments/expenditures

INFORMATION ABOUT THE CITY

The City of Liberty Lake serves approximately 9,900 residents in Spokane County. It provides an array of services including public safety, library, street maintenance and improvements, parks and recreation, planning, zoning, code enforcement and general administrative services. The City contracts with Spokane County for court services, jail services, emergency management services, dispatch services, street maintenance, and animal control.

An elected, seven-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its 59 employees. For fiscal years 2016, the City operated on an annual budget of approximately \$11.9 million.
